Explanation of Responses:

1. On January 28, 2011, the reporting person was granted 3,586 performance-based restricted stock units ("Performance RSUs"). The Reporting Person may earn from 0-200% of his target amount of Performance RSUs depending on the extent of Carnival Corporation & plc's earnings per share growth over the three-year performance period ending with fiscal 2013, subject to his continued employment during the performance period (with earlier partial vesting in certain cases upon eligibility for retirement, or death or disability, prior to the expiration of the performance period). Because, as of the date of the grant, the Reporting Person was eligible for retirement due to his age, 1,435 Performance RSU's vested on January 28, 2011.
2. Represents a surrender of shares to satisfy tax obligation on the vesting of the Performance RSUs.
